## Why compare?

- Comparison of development of homelessness in the Nordic Countries
  - Denmark, Sweden, Norway and Finland
  - Individual data
- Similar societies: Nordic welfare states
  - If one country have reduced a problem, the other countries can do it too
- First step in solving the problem: Measure the problem




#### Methodology

- Comparison of national countings in Denmark, Norway,
  Sweden and Finland
- Denmark: Every 2nd year: Several organizations with homeless clients answers a survey for each of their homeless clients in week 6
- Sweden and Norway: Similar to the Danish methodology
- Finland: Survey answered by municipalities every year. Data from e.g. rental apartments and social service
  - Different methodology, reduces comparability
  - Not all variables available for Finland
- Disclaimer: Not easy to find all homeless people => do not overinterpret the results



## Homelessness in the Nordic countries


- Quite dramatic developments
  - Increasing frequency in Denmark and in Sweden
  - Decreasing frequency in Finland and especially in Norway





#### Youth homelessness


- In these three countries: More likely for youth than for others to be homeless
- Very different developments in Denmark and Norway





#### Duration of homelessness


 Longer duration of homelessness in Denmark and Sweden than in Norway





## Types of homelessness


- Large differences between Finland and the other countries
  - Beware of the counting methodology





# Development of street homelessness


- Dramatic reductions in street homelessness in Finland over a decade
  - Maybe the most important result





### Homelessness and gender


 Increasing share of females in Denmark, Sweden and Norway - why?





# Homelessness and mental/physical health


- Rapid increase in share with mental illness in Denmark
  - Danish reform removes early retirement schemes for people younger than 40 (in 2013 however)





## Homelessness and substance abuse


- Massive substance abuse among homeless people
  - General reductions in share





#### Homelessness and income


- Small minorities of homeless people have work or study income
  - Unexplained variations among countries

# Concentration of homeless in the four largest cities


- Def.: Share of homeless in major cities / population share of major cities
  - Major cities attracts homeless people in all countries
  - Higher level in Finland than in other countries





### Homelessness and origin

- Foreigners are more exposed to homelessness
  - Convergence among countries, but still highest level in Denmark
