### SITE VISIT 1: Hogeschool Utrecht/ University of Applied Sciences

In this workshop, we facilitate a dialogue about moral dilemmas and ethical questions that arise when doing research on the theme of homelessness and housing exclusion. For example, questions like *'We want to work with experts by experience as co-researchers, but funders don't give money to pay them: what now?'* or *'We need to share data about homeless persons to convince policymakers to build more houses, but data sharing means violating privacy legislation: what should we do?'*

Stakeholders with different, often conflicting interests, all have their own perspective on what should be done (and who should do what) in complex situations. This is why it is often very difficult to find a solution for problems, come to satisfactory agreements, and learn together. Moral Case Deliberation (MCD) has proven to be a valuable tool, to share experiences and opinions. An experienced facilitator structures the conversation in order to guarantee that every voice is heard and everyone's input is equally weighed.

Participants in this workshop can have different professions/positions (researchers, policy-makers, experts by experience). They will see that they are not alone in their ethical struggles and find out that there are more perspectives than they were aware of.

What to see: [Oranje Huis Utrecht - Moviera](#). On April 29, 2022, Moviera officially opened the Orange House in Utrecht. Here, they offer (emergency) shelter to clients and children who have (had) to deal with domestic violence or trafficking. They also offer ambulatory help from this location: help at home or at another location. They work with a systemic and gender sensitive approach and also offer the perpetrators individual ambulatory support in the cases that they are open to this kind of support and when it is safe to do so. The empowerment of women and their children is one of the key notions of our systemic approach: strengthening their individual, social and economic position are key to breaking the cycle.

During this visit we will show you around at our facility De Boerderij, and will present to you our practice in our FIT team (Flexible Integrated Team). **De Boerderij** (The Farm) is an innovative facility where people with a psychiatric and/or addiction background reside. They have often lived 'alongside' society and on the streets for a long time. They may have a history of long-term admissions to a (secure) psychiatric environment or have been in detention. **Lister FIT** The Lister Flexible Integrated Team is a true assertive outreach team. We initiate support when there are complex issues where nuisance and addiction problems, as well as homelessness, play a major role. FIT approaches support in an out-of-the-box manner, where previous care trajectories have stalled. Our goal is to reduce nuisance and to get clients back into care/support.
